Summary

This report shows how much each California State Senator and Assembly Member accepted in political contributions from alcohol industry interests in the 2003-2004 legislative session. The Marin Institute gathered and organized this data to reveal the alcohol industry's significant influence on California Legislators and the political process. While some legislators took nothing, most accepted thousands of dollars in contributions—more than \$400,000 total—from sources that include companies such as Anheuser-Busch and Coors, and trade organizations like the California Beer and Beverage Distributors and the Distilled Spirits Council.
